**Product Name :** Ant, Roach, & Spider Residual Insecticide with Dursban®

**Description :** This product is a combination of insecticides offering quick knockdown and residual kill of cockroaches for up to 4 Weeks. Also for, residual and contact control of Crickets, Silverfish, Clover Mites, Centipedes, Millipedes, Firebrats, Earwigs, Sowbugs, Spiders, Brown Dog Ticks, Lone Star, Ticks, Ants, Carpet Beetles, Fleas. (Note: It is a violation of federal law to use this product in a manner inconsistent with its labeling. See product label copy for specific information.)

**Where to Use :** For use in non-food areas indoors and outside premises of hotels, motels, homes, preschools, commercial, office, institutional and storage buildings, recreational buildings, ship cabins and hospitals. This product can be used in non-food areas only, such as corridors, offices, foyers, lavatories, garages, storage rooms, and basements of packaging and processing plants, supermarkets, restaurants, bottling plants, canneries, flour and feed mills, and bakeries. Also for use in and around campers, mobile homes, buses and automobiles. This product can be used in cargo planes, trucks, boxcars and ship cargo holds only if the vehicles are not used for transport of food or food products at any time. Also for use in dog kennels, and horse stables. (Do not spray on horses and dogs. Do not spray dog and horse food or feed items.)

**CAUTION:** Harmful if swallowed. Avoid contact with eyes, skin or clothing. Wash hands after using. Do not contaminate food or feedstuffs with this spray. Do not allow spray to contact food, feedstuffs, or supplies. Thoroughly wash food contact surfaces with soap and water if they become contaminated by application of this product. Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish bowls (tanks) before spraying. This product is toxic to fish. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes. Do not use this product in edible product areas of food processing plants, restaurants or other areas where food is commercially processed or prepared. Do not use in serving areas while food is exposed. **IF SWALLOWED:** Get immediate medical attention. **IF IN EYES OR ON SKIN:** Flush with plenty of water. **FOR EYES:** Get medical attention. **NOTE TO PHYSICIAN:** Chlorpyrifos is a cholinesterase inhibitor. If symptoms of cholinesterase inhibition appear, atropine only by injection is an antidote.

**Spill Or Leakage Procedures :** Wear protective clothing during clean up procedures. Avoid breathing vapors. Toxic to fish, birds and wildlife. Contain spill by diking. Keep out of sewers. Suck up with wet/dry vac. Dispose of in accordance with all local, state and federal regulations.
