G-TWK WEED CONTROL is a non-selective herbicide for controlling a wide range of annual and perennial weeds and grasses. It is recommended only for non-cropland areas, such as railroad rights-of-way and industrial areas. The application of 200 to 400 pounds of this product per acre usually results in a nonproductive condition of the soil for a period of a year or more. The duration of non-productivity is dependent upon rainfall, type of soil and other conditions.

DIRECTIONS: Apply product as furnished using a seed spreader, fertilizer spreader, shaker type applicator or any equipment which will distribute this product uniformly over the area to be treated.

To control annual and most perennial weeds and grasses, apply at the rate of 200 to 400 pounds per acre; on smaller plots, 0.5# to 1# pound per 100 square feet. Repeat spot treatment may be required when deep rooted perennial weeds are present. To obtain best results, apply to the ground where it will be absorbed by the roots. Applications early in the season have been found to give results superior to applications made later in the season. This product may, however, be applied at any time of the year. Maximum effectiveness in arid regions is obtained when applied just prior to the rainy season.

Users should consult State Agricultural Experimental Stations or Extension Service Weed specialists for recommendations as to use of this product in their particular area.
